The Nebraska Department of Environment and Energy (NDEE) has reviewed the January 8, 2021 CQA Report for the above-referenced facility, certified by a registered professional engineer in the State of Nebraska and submitted on your behalf by SCS Engineers. The Department approves the CQA Report as written. The CQA Report describes the soil source, surface preparation, the subbase preparation, seeding, and erosion controls. It also includes daily reports, photographic logs, material density testing, and an as-built survey with associated data. The NDEE conducted a final inspection on January 14, 2021, and the construction appeared to be completed as described in the CQA Report. NDEE previously approved the Phase 2 closure on March 5, 2018 and the Phase 1 closure on March 13, 2017; therefore, NDEE is approving the final closure of this facility.

The start of the 30-year post-closure period for the OPPD Nebraska City Station Unit 1 FFCA Landfill will begin as of the date of this letter. Post-closure must be implemented in accordance with the approved post-closure plan in your permit application. Please keep a record of the annual post-closure inspections on a form that you have developed. Any repairs or maintenance that is completed during post-closure should also be documented. If erosion occurs on the final cover after a major storm event, repair of the final cover and reseedling should occur as soon as possible.

Final Closure documentation to be submitted includes the following items:

- Within 90 days following the installation of the final cover system, documentation that a permanent notation on the deed, or other permanent property record or instrument normally examined during a title search, has been recorded in the permanent records of the county Register of Deeds, as required by Nebraska Administrative Code, Integrated Solid Waste Management Regulations (Title 132), Chapter 4, Section 005.02. Please see the enclosed sample forms for the Notice in Deed and the Certification of Deed Notice.

Upon receiving the documentation of the deed notice and the certification of deed notice NDEE will release OPPD from the closure financial assurance requirements of the Title 132, Chapter 8.

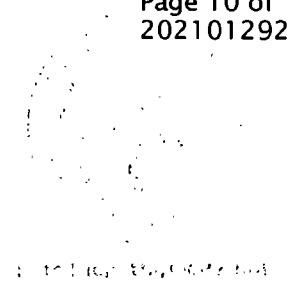
